It was pointed out that while AI is often better at spotting issues, it often highlights different issues than a human would.

The Guardians commented that they believed that everything possible had been thought through, and that they would like regular updates as the work begins.

"New Guardians" 14.30-14.45	 Summary Since two Guardians had completed the end of two terms as Guardians and. left the Guardian Council the Council has been short of at least a couple of members. It had been agreed some time ago that we should step up our recruitment efforts, and a shortlist of candidates had been provided by the former Guardians. prior to their departure. Out of the shortlist, following desk-based research, during the last Guardian Council meeting it was decided to approach four of the nominees. However, it has proved challenging making contact and the process has been delayed considerably as a result.
	 Discussion It was agreed to try to contact the previous Guardians to try and get the process moving again. It was also agreed that the Guardian Convenor would do the initial introductory call, and if the candidate was deemed suitable that they would proceed to a further call with Yoti management representatives. In parallel with our current recruitment approach, it was decided to compile a Guardian recruitment pack, in a similar vein to that used in the Yoti Fellowship Programme, and to experiment with a more open recruitment process over the coming weeks.
